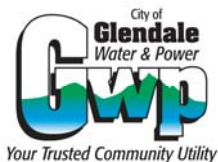
* "In Glendale Purchase" means that the appliance or product was purchased from a place of business that is physically located within the cities of Glendale, La Crescenta or Montrose as defined by U.S. Postal Service zip codes.

**If you have received rebates for three Ultra Low Flush Toilets from GWP in the past, the HET rebate will be in the amount of \$30 for out of Glendale purchases and \$40 for in Glendale purchases.

PLEASE NOTE: Rebates for Single Speed High Efficiency Pool Pumps were discontinued as of March 13, 2009. Qualifying applications for high efficiency single speed pool pump rebates will continue to be honored through October 1, 2009. Rebate applications for single speed pool pumps received after October 1, 2009, will not be accepted.

ENERGY STAR qualified products meet strict energy efficiency guidelines set by the EPA and US Department of Energy. These guidelines can change each year. As an ENERGY STAR partner, GWP will honor these updated guidelines and will follow them when processing rebates.

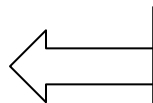
Smart Home Appliance Rebate Program Application Instructions

Please read these instructions carefully before submitting your application. Incomplete applications may delay payment of your rebate.

To receive a rebate for your qualifying purchase:

1. Complete and sign the enclosed Smart Home Appliance Rebate Program Application.
2. Attach originals or legible copies of the following:
 - Receipt or invoice for the appliance or product purchased.
 - Receipt or invoice must include the brand name, model number, purchase date, purchase price, and retailer or contractor location. Please see below for additional requirements for toilets, windows, central air conditioners, ceiling fans, and compact fluorescent torchieres.
 - A current Glendale *Water & Power* bill for the address where the product or appliance is installed.

Additional Documentation Requirements for Specific Products

- **High Efficiency Toilet (HET) Rebates** - Only toilets from the qualifying product list at <http://socalwatersmart.com/index.php> are eligible. If the receipt or invoice is not specific, you **MUST** attach additional documentation such as the owner's manual, installation instructions, or the label from the box indicating the brand and model number of the toilet. PLEASE NOTE: If you have received rebate(s) for Ultra Low Flush toilet(s) in the past, a reduced rebate level may apply.
- **Ultra Low Flush Toilet (ULFT) Rebates** - If the receipt or invoice is not specific, you **MUST** attach additional documentation such as the owner's manual, installation instructions, or the label from the box indicating the brand and model number of the toilet.
- **High Performance Windows** – **A copy of your City of Glendale Building Permit must be submitted with the application.** In addition, one of the following forms of documentation must be submitted with your paid invoice:
 - o The NFRC label for each window with the U-factor and SHGC values on each label. (The NFRC label is typically attached to each window as an easily removable sticker.) The dimensions (width & height) for each window must also be included.
 - o Your Home Improvement Contract or paid invoice from the contractor including the dimensions, U-factor, and SHGC for each window installed.
 - o The manufacturer's order confirmation provided by your contractor. This document must be on the window manufacturer's letterhead and include U-factor, SHGC and dimensions for each window.
- **Central Air Conditioners**
 - o The receipt or paid invoice must include the condenser brand and model number, the coil brand and model number, the SEER rating, and the tonnage.
 - o The invoice must include the ARI reference number for the system installed.
- **Ceiling Fans & Compact Fluorescent Torchieres**
 - o In addition to the receipt, please provide documentation showing brand, model number and Energy Star logo. Examples include: owner's manual, portions of the box or other packaging.
