# Instructions for Completing Solar Solutions Application

## Section 1. Customer Information

Provide the customer name, complete service address of installation, telephone, fax number, email address, and GWP electric account.

## Section 2. Contractor/Installer Information

Check the appropriate box for whether the system is to be installed by a contractor or self-installed. If installed by a contractor, provide the contractor's license class, number, expiration date, company name, address, and contact information. If self-installed, electricians assistance is recommended. Electrician is required to have State Contractor License and City Business License. For additional permit information please contact Building and Safety Department at (818) 548-3200.

## Section 3. System Information

Check appropriate box applying to system being installed.

## Section 4. Solar Photovoltaic System Equipment

Provide the name of inverter and PV module manufacturer, model, quantity, power rating watts, and efficiency. Include the type of PV Array (Fixed, Single-Axis, Dual-Axis), Azimuth or orientation, Tilt angle, and Estimated Annual kWh output.
